Note: The U.S. Department of State publishes annually *Treaties in Force* that provides information on treaties and other international agreements to which the United States is presently a party. It lists those treaties and other international agreements in force for the U.S. as of the stated publication date for each edition. The Chinese Ministry of Foreign Affairs adopts a different style in publishing multilateral treaties to which China is a signatory party. Since there is no clear date of "in force" for China, we only mark the date of treaty accession, signing, or acceptance in the table and we are not completely sure whether the treaty is factually in force or not.
